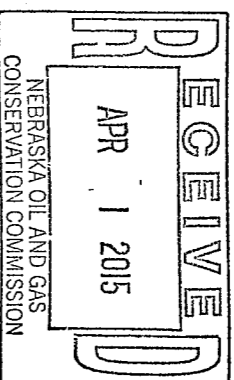

APPLICATION

COMES NOW Roxanna Nebraska, LLC, Applicant in the above-entitled cause, and herewith represents unto this Honorable Commission, as follows:

1. Applicant is a Limited Liability Company organized and existing under and by virtue of the laws of Texas, having its principal place of business at 952 Echo Ln. Suite 364, Houston, Texas 77024, and is duly authorized to transact business in the State of Nebraska.
2. Pursuant to an Application filed October 1, 2014, and after Notice and Hearing, Order No. R-888 was entered in Case No. 14-22 on October 28, 2014, establishing an 80-acre drilling and spacing unit for the production of oil and gas from the Hunton Formation, underlying the following described lands:
 

Township 1 North, Range 16 East of the 6th P.M.,  
Richardson County, Nebraska  
Section 17: Part of the N/2NW/4  
Section 18: Part of the N/2NE/4
3. Specifically, the spacing unit as approved by said Order consisting of 80-acres, begins at the Northwest Corner of Section Seventeen (17), Township One (1) North, Range Sixteen (16) East of the 6<sup>th</sup> P.M., thence Eastward 1,650 feet, thence South 1,056 feet, thence West 3,300 feet, thence North 1,056 feet, thence East 1,650 feet to the point or origin at the Northwest Corner of Section Seventeen (17).
4. The proposed initial test well was to have a surface location in the North Half Northwest Quarter (N/2NW/4) of Section Seventeen (17) with the bottom hole

- location being in the North Half Northeast Quarter (N/2NE/4) of Section Eighteen (18), to be drilled to 2,320 true vertical depth and 4,950 measured depth, with said test well to be completed from intervals no closer than 300 feet from the boundaries of the 80-acre spacing unit.
5. Said prior Order No. R-888 entered on October 28, 2014 provided that the Commission shall retain jurisdiction, reserving the right to enter such further Orders as may be necessary to protect correlative rights and prevent waste.
6. Applicant has no current intention to drill the previously approved and described Well.
7. Applicant is filing with this Commission, an Application for an 80-acre spacing unit to be located in the East Half Southeast Quarter (E/2SE/4) of Section Seven (7) and in the East Half Northeast Quarter (E/2NE/4) of Section Eighteen (18), Township One (1) North, Range Sixteen (16) East of the 6<sup>th</sup> P.M., Richardson County, Nebraska, which proposed spacing unit will not conform with the previously approved spacing unit entered by Order No. R-888, and will in fact be in direct conflict to the previously approved Order of the Commission.
8. Attached hereto, marked Exhibit "A" and by this reference specifically incorporated herein, is a tabulation showing the names and addresses of each owner as defined in the Act, or Operator, as shown by the Commission Records of the land within the previous spacing area approved by Order No. R-888 in Case No. 14-22 on October 28, 2014, together with the names and addresses of each owner as defined in the Act, or Operator, as shown by the Commission Records of all Governmental Quarter Sections or Lots equivalent thereto, constituting the previous "offset or boundary area" of the previously approved 80-acre spacing tract, directly or diagonally offsetting the previously approved spacing area, and including each person owning a fee, leasehold, mineral or royalty interest, all as disclosed by the Public Records of Richardson County, Nebraska.  
**WHEREFORE**, Applicant prays that the Application be set for hearing, that notice of the pendency thereof be given in the manner provided by law and upon the evidence presented at such hearing, an Order be made and entered as follows:

A. Rescinding previous Order No. R-888 entered on October 28, 2014 in Case No. 14-22;

B. Confirming that the previously ordered 80-acre spacing unit described as follows:

Township 1 North, Range 16 East of the 6<sup>th</sup> P.M.,  
Richardson County, Nebraska:

Section 18 and 17: Beginning at the Northwest Corner of Section Seventeen (17), Township One (1) North, Range Sixteen (16) East of the 6<sup>th</sup> P.M., Richardson County, Nebraska, thence Eastward 1,650 feet, thence South 1,056 feet, thence West 3,300 feet, thence North 1,056 feet, thence East 1,650 feet to the point of origin at the Northwest Corner of Section Seventeen (17), Township One (1) North, Range Sixteen (16) East of the 6<sup>th</sup> P.M., Richardson County, Nebraska

is no longer subject to any spacing Order and in particular, is no longer subject to Order No. R-888 entered in Case No. 14-22 on October 28, 2014.

C. For such other and further Orders as may be just and equitable in the premises.
