A P P L I C A T I O N

Comes now the Nebraska Oil and Gas Conservation Commission,
petitioner, and states as follows:

1. That Commission rule 3.004 requires operators to make, or cause to be made, and file with the Commission a good and sufficient bond in the sum of not less than ten thousand dollars (\$10,000) for each well or hole and payable to the State of Nebraska, conditioned for the performance of the duty to comply with all the provisions of the laws of the State of Nebraska and the rules, regulations and orders of the Commission. Said bond shall remain in force and effect until plugging of said well or hole is approved by the Director or authorized deputy, a new bond is filed by a successor in interest or the bond is released by the Director. It is provided, however, that any owner in lieu of such bond may file with the Director a good and sufficient blanket bond in the principal sum of not less than one hundred thousand dollars (\$100,000) covering all wells or holes drilling or to be drilled in the State of Nebraska by the principal in said bond; and upon acceptance and approval by the Director of such blanket bond, said bond shall be considered as compliance with the foregoing provisions requiring an individual well or hole bond.
2. That the Commission wishes to take control of certain wells operated by RV Borchert Oil Producer and plug and abandon these wells and restore these lands to agricultural use using the bond funds and other monies controlled by the Commission.

3. Attached hereto, and marked Exhibit "A", is a list of the wells/leases operated by RV Borchert Oil Producer.
4. That the Commission has requested RV Borchert Oil Producer to abide by the desire of the Commission to plug and abandon the wells and to surrender its posted bond.
5. That all commercially economic leases and wells have been transferred to other Operators.

NOW, THEREFORE, it is ordered that this application be set down for hearing at 10:00 a.m., April 22, 2025, at the Commission office, 1625 Dorwart Drive, Sidney, Nebraska
